NEWS UPDATE

QC Applications

From 6 March 2013, the Queen's Counsel Selection Panel has been taking applications for appointment as Queen's Counsel in 2014, from suitably qualified practitioners. The application form and Guidance for Applicants can be downloaded from the QCA website at <u>www.qcappointments.org</u>. The closing date for applications is 5pm on Wednesday 17th April 2013. On current expectations the outcome of the applications is likely to be announced in the early part of 2014.

The Panel welcomes applications from groups that are under-represented in Silk including women, members of ethnic minorities and people with disabilities. They are also welcome applications from solicitor advocates and <u>employed advocates</u>. The Secretariat is happy to answer any queries or provide advice on the process or on making an application. Admission in Scotland

As many of you will be aware, not only are English barristers refused rights of audience before Scottish Courts and certain tribunals - the Faculty of Advocates will not even allow temporary admission on a case by case basis. The International Committee of the Bar Council is currently reviewing this problem and considering the steps it might take to facilitate change in relation to this matter. In that context, it would help if members could provide information regarding if in the past, they been in a position where they could have represented clients in Scottish courts or Tribunals, had it not been for the above mentioned restrictions.

If members could briefly identify generically the type of case(s), the relevant court(s)/tribunal(s) and time(s) (e.g. appeal from Employment Appeals Tribunal Glasgow to Court of Session in 2011) and email JHargreave@barcouncil.org.uk using the subject line: "Scotland", that would be greatly appreciated. All information will be treated in strict confidence.

Law Reform Committee Essay

The Law Reform Committee of the General Council of the Bar organises an annual Essay Competition designed to encourage and foster an interest in law reform. The Competition is open to Pupil barristers; BPTC students; CPE/GDL students; and Qualifying law degree students and those aiming for a career at the Bar. Entrants are invited to submit an essay of not more than 3,000 words that identifies and makes the case for a law reform that is desirable, practical and useful. The Competition is sponsored by the Bar Council Scholarship Trust and the prizes are £4,000 for the winner; £2,500 for the runner up; £1,500 for the best CPE/GDL student entry; £1,000 for the runner up CPE/GDL entry; and 2 x £500 high commended awards.

Closing date for the competition is 17:00 on 10 October 2013. The prizes will be presented immediately after the Annual Law Reform Lecture, which this year will be given by The Lord Chief Justice of England and Wales - The Rt Hon Lord Judge on Thursday 21 November 2013 at 17:30 in Inner Temple Hall.
