#### DENNING LECTURE AND CHRISTMAS RECEPTION



The 2018 Denning Lecture was given by Sir Christopher Clarke, who had previously been the Head of the Commercial Court, and who had earlier this year retired from the Court of Appeal. His chosen title was: "The English Courts – good for future business?". As Lady Hale, the BACFI President, who chaired the evening noted, whereas she can say nothing on Brexit in her role as the Head of the Supreme Court, Sir Christopher, now no longer in judicial office, can speak much more freely.

His lecture was truly masterful on the potential threats and opportunities waiting in the coming years for the English Courts. Not merely narrowly focussing on the potential hazards to the pre-eminence of the English Commercial Courts that Brexit presents and contemplating the encroachment from other jurisdictions, such as Singapore, who are keen to get a slice of the judicial action that currently flows through London; he also discussed the advances in technology and how they can be harnessed; as well as the recently announced reforms to disclosure and online courts.

Overall though, Sir Christopher was optimistic that the English Courts will adapt and keep ahead of the following pack. This is in no small part due to the excellent and incorruptible judiciary that we enjoy in this country, which sadly no longer number Sir Christopher amongst their top ranks – but at least his excellent judgment is still being deployed as an International Arbitrator! Another excellent and thought provoking Denning Lecture.

# Risk to the employed person in a regulated environment: 2 November

In today's World, we are all faced with a barrage of regulation. This regulation comes at us from many directions: through the detailed implementation of legislation, the rules of our own professional bodies and regulators more widely. Sometimes, this regulation is well thought through and focuses on the problem it is designed to cure. Other times, it can be ill-perceived, poorly implemented and create many unintended consequences. As professionals we have to work our way through this minefield of conflicts and unintended consequences.

The first collaboration between ACCA and BACFI provided the audience with an invaluable opportunity to reflect on the "Risk to the employed person in a regulated environment". Our pack included Lorinda Long's "view from the trenches". The cold sweats at the mere mention of MiFID II were noted. Lorinda's comments around "if it ain't broke, fit it" resonated with a number of us.

Brian McEnery (President of ACCA) gave us an insightful presentation on the need for regulation and the view from the regulator. How often does one get the opportunity to hear first-hand from someone with such a deep and diverse range of regulatory experience? For one, I will not forget his "Blame Index" nor his closing remarks on how the regulators need to strive to get it correct. This was followed by Paul Ozin QC's reflections on the recent Supreme Court decision on Ivey. The changes to the test for dishonesty is a timely and necessary reminder of how the regulatory rules can change so quickly. Many thanks to ACCA for hosting this event. ## **Professional Issues Update**

The Bar Standards Board has made some amendments to the third edition of the BSB Handbook. There was an anomaly in rule S21 which provided that employed barristers providing legal services, exercising a right of audience or conducting litigation for their employers needed to have a Qualified Person if they were of less than one year standing. The words "providing legal services" have now been deleted so that one year's standing is only required for those employed barristers exercising a right of audience or conduction litigation.

### Employed Barristers now insured for Pro Bono work

Employed barristers will now be allowed to carry out pro bono work as the Bar Council's call for professional indemnity insurance (PII) extension to cover the employed Bar has been approved by Bar Mutual.

Under the rule change, approved at the Bar Mutual Annual General Meeting, employed barristers will now be covered by PII to carry out pro bono work via the Bar Pro Bono Unit or the Free Representation Unit.

Previously, employed barristers were prevented from taking up pro bono work because of the short fall in their insurance.

Lucinda Orr, Chair of the Employed Barristers' Committee said:

"Pro bono has a vital role to play in assisting members of the public who cannot afford or access the legal advice they often desperately need - the employed bar has many talented lawyers whose skills can now be deployed to help such people, and I am thrilled that the employed bar will now be able to contribute in this critical area."
