#### **PROFESSIONAL NEWS**

The **Legal Education and Training Review** commissioned by the LSB, is proceeding slowly and BACFI is preparing for a meeting with its researchers on 20th September. We have already held an "awayday" meeting for officers, the general committee and Vice Presidents and have begun to draft a major response which will set out BACFI's stance on the future of the Bar.

**BACFI's vision for the future of the Bar** is likely to be radical. Vice Presidents in particular, who have after all lived through a good many changes to the legal profession, are adamant that we should embrace this opportunity for change wholeheartedly and suggest a blueprint for the 21<sup>st</sup> century Bar. Informed by our members' survey, here are the principal planks emerging from our ongoing discussions:

- The Bar should be setting a gold standard for technical excellence and ethical conduct, and supporting an increase in the global recognition of English legal qualifications.
- There must be fair and open access to the profession, drawing from the widest possible talent pool.
- The Bar must serve the needs of "consumers" (varying from retail to B2B) in imaginative and efficient ways.

- The Bar must remain a leading contributor to the worldwide Rule of Law, and contribute with solicitors to increasing the global footprint of English law as the governing law of choice, internationally.
- Whilst we do not consider that forced fusion of the two principal branches of the legal profession is desirable, BACFI recognises that in time and through common training, solicitors and barristers will become distinguishable solely by their specialisms.
- BACFI favours a common, high quality initial period of professional training that would lead to full, basic legal qualifications; thus ending the misery of Barristers without pupilage.
- A first stage of common academic training, which could be undertaken by undergraduates (law degree), postgraduate (non law degree) or suitably qualified and experienced non graduates (Legal Executives, immigration advisers, probation officers, police officers, court clerks, etc)
- A second stage of common "blended learning for lawyers" which would incorporate technical learning, legal practice and ethics and could be undertaken using part time, shared and day release programmes by accredited firms (solicitors, barristers, ABS, commercial firms, government agencies, etc), leading to full and transferable qualifications as an "English Lawyer". After completion of this stage, which could last from 2-5 years, Barristers could be called to the Bar and Solicitors admitted to the Roll and could thereafter commence work with PQ status in professional or commercial firms or chambers.
- A lifetime commitment to continuing professional development, either for the maintenance of stage 2 basic training (eg after maternity or other long absences) or for acquired specialisms (at any time in a lawyer's career), one of which would be trial advocacy - undertaken with the Inns of Court. CPD should also incorporate other forms of accreditation (child case handling, mediation, advanced litigation or anything else currently requiring additional qualification and training such as FSA qualifications or specialist training required by employers.

### **PROFESSIONAL ISSUES**

### Representation

BACFI has put in formal responses to the following consultations recently: Response to the BSB Code of Conduct and Handbook, holding repose to LETR. They can be found on the <u>website</u>.

#### Education

**CPD seminars:** BACFI remains an accredited provider of CPD seminars and we have ensured that events in our current **2012 programme** will qualify for maximum points.

We are currently in talks with the C&I Group (which runs countrywide CPD seminars for its members) to explore access for BACFI members to C&I Lectures and seminars outside London.

### Support

**Pupillages:** we are still continuing to press for better and more user friendly BSB rules to ATOs, to encourage commercial firms to apply for accreditation or to sponsor pupils in more imaginative ways. A Council of the Inns of Court (COIC) committee is also lobbying the BSB to allow sponsored pupilages and BACFI has indicated its general support for this idea. However, the COIC proposals do not go nearly far enough and will only initially benefit the publicly funded Bar.
