#### **Employed Barristers Interim Statement**

This document has been produced by the BSB further to the consultation on the definition of an employed barrister. The purpose of the statement is to provide guidance on those barristers whose current working practices may constitute a technical breach of the rules, whilst the BSB considers amending its rules. A rule change submission to the LSB is expected in March 2016 (the LSB is then likely to take a further 3 months to consider it). In the interim period, the BSB will take a risk-based approach to any barrister who may be in technical breach of r.S39.

#### **CLS BACFI Prize Winner**

The top student in Commercial Law this year was Dr George Molyneaux who achieved an overall grade of Outstanding whilst on the BPTC and is currently undertaking pupillage at Blackstone Chambers.

He was presented with his cheque by the Chair, Lucinda Orr on 2 December 2015 at a ceremony at City Law School.
